We have seen in a short time period the reorganization of BPW/USA and BPW Foundation into a single entity. The Louisiana Federation during the State Conference June 2009 voted to stay the course and support the new merged organization. Within our state we continue to face changes as local organizations go their own way and new members come on board with the understanding that they are joining a new more streamlined BPW that has taken the mission statement as an edict to get back to basics. In 2009 we are finding that women's rights are not as secure as one would hope. Financial decisions in budgets throughout our state and on the federal level are not a direct attack on rights but by not funding programs that support women causing as much damage. Domestic vio-

lence support programs are being cut. Title IX is under a threat of cuts that are not equal between programs at colleges. The Equal Rights Amendment is only a few states shy of being passed and Louisiana is one of those states that have not stepped up to the bar. Equal Pay saw great strides forward with the Lilly Ledbetter Act however our state continues to sideline the issue. We are a powerful voice if we unite and speak to our legislators. We are strong if we continue to provide education to women so that they can further their careers. We are a support to each other through networking and friendships. We are the Louisiana Federation of Business and Professional Women. I look forward to a year of great changes and a group who has stood the test of time and will continue for the next ninety years.

## SWC District talks BPW

The Southwest Central District's Fall meeting held in Monroe on Saturday, Sept. 26, 2009 focused on BPW's recent merger and what BPW means to me. We did not use an outside speaker as we felt it was important to let the membership voice their concerns about matters that affected them.

One area we discussed was: what was working well since the merger and what seemed to be a problem. The working well area comments included we haven't seen much difference; we were happy and relieved that BPW Foundation negotiated the number of members for the assessment (since we have lost some LOs and members since June); the emails seem to be better; we are more satisfied that we can set up our own legislative platform so that it fits us better; and we feel we have more control at state level.

On the problem side, comments included that there was not enough communication from Foundation regarding the merger and terms; we have lost our central information depot—many things we were used to finding on the BPW/USA website aren't there or we can't find them; we need more program diversity on the state level; there is no communication of who is in charge at Foundation to LO members; we feel disconnected to National; we need more definition on how the structure at Foundation works with us; and we need more information on how the Foundation trustees are selected.

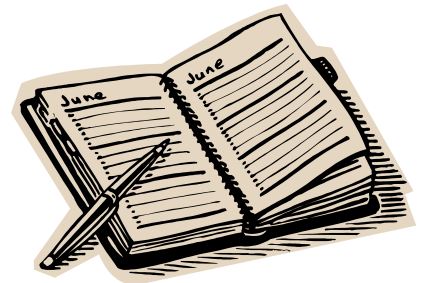
