

Since Mid-Year Board Meeting in January 2006, the emphasis for BPW/LA has been planning the rest of the year which will be highlighting Equal Pay, Young Careerist, and Indiviual Development, membership growth, Black History Month, and Women's History Month.

At Mid Year Board, the Saturday luncheon speaker was Joe Wood Berry, a professional lobbyist from 'the Lake Charles, LA area who spoke to us about advocating for our issues effectively.

After Mid-Year Board, Angela Jackson-Wilson, our state president attended Policy and Action in Washington, DC in February. I was unable to attend because of my health, but Angie did us proud and came back with lots of good information about our legislative issues and BPW training. She visited the offices of Representative Rodney Alexander and

Representative Melancon where she advocated for our issues.

Plans are presently underway for the big Economic Recovery Summit and Equal Pay Day Commeration that will be held on Saturday, April 22, 2006 from 10-3 PM at Mike Anderson Restaurant in Baton Rouge with State Representative Syndie Mae Durand from Lafayette and Representative Willie Hunter, Jr from Monroe who will lead the discussion about advocating for the Equal Pay Act in Louisiana. Hunter is the author of HB 144 for Equal Pay for Women and is sponsoring this bill through the Louisiana Labor Relations Committee of which he is chair. The Recovery Summit will have speakers from various government agencies and will discuss how women of Louisiana can get help for their needs from Katrina and Rita and future disasters that may strike our state. Everyone is invited to come to this most important event. Camille Moran, Immediate Past State President and Equal Pay Day/ERA Coordinator is chairing this interesting program. Please make plans to attend.

As Legislation Chair, I encourage everyone to plan a Equal Pay Day event. This is one of our most important events of our club year. Go to BPW/

USA website (www.bpwusa.org) and look for ideas and help with your local event. At the state conference in Lafayette I will be giving Legislation Awards and also Equal Pay and ERA Awards. Look at the awards criteria on page 36-37 of the board book. They should be postmarked no later than May 1, 2006 and sent to me at my address below.

# BUSINESS AND PROFESSIONAL WON

On Thursday, February 2nd, I along with over 200 other members and supporters of Business and Professional Women/ USA (BPW/USA visited Capitol Hill to lobby on behalf of the organization's national legislative platform. The lobby day kicked off the 2006 BPW/USA Policy & Action Conference: Changing Policies That Impact Workplaces.

The three bills for which we lobbied were Johanna's Law, The Healthy Families Act and the Retirement Security for Life Act. The lobby day included advocacy training, an expert panel discussion about the three bills and a luncheon on Capitol Hill. The expert panelists who discussed the three bills were Cindy Hounsell, Executive Director of WISER, Sheryl Silver, Founder and President of Alliance for Women's Cancer Awareness and Holly Fechner, Policy Director and Chief Labor & Pensions Counsel for the Senate Health, Education, Labor & Pensions Committee.

Senator Debbie Stabenow (D-MI) addressed the conference attendees during the luncheon preceding the lobby visits on an upcoming bill "the HEART for Women Act. The bill is supported by Business and Profes-

sional Women/USA (BPW/USA) because of the need for increased research on heart disease and its unique impact upon women. The HEART for Women Act would "amend the Public Health Service Act to improve the prevention, diagnosis, and treatment of heart disease, stroke and other cardiovascular diseases in women."

Following the luncheon, I visited the offices of Senator Mary Landrieu, (D-LA), Congressman Charles Melancon, (D-LA 3<sup>rd</sup> District) and Congressman Rodney Alexander.(R-LA 5<sup>th</sup> District)

the Senator or either of the Congressmen personally, their legislative staff was eager to listen to our positions on the three bills and the legislative agenda of BPW/LA.

The lobby day closed with a BPW/PAC event featuring pollsters Celinda Lake and Kellyanne Conway, authors of the book, "What Women Really Want", which has been featured on the Today Show.

BPW/USA CEO Deborah Frett characterized the conference as a catalyst for women to become change agents. "The Policy & Action Conference allows our membership and working women to present a unified front to elected leaders and policymakers on the issues that impact women nationwide," explains Frett.

This year an online tool was offered, the Advocacy Classroom created by Advocacy Associates, to prepare conference attendees for their lobby visits., The tool easily and clearly outlined the legislation as well as how to lobby on Capitol Hill

A special research and education day was held on Friday, February 3rd featuring employers and organizations that are re-shaping and re-thinking workplaces as a result of policy. Participants had a selection of workshops to attend and the option to receive continuing education units.

The Board of Directors meeting was held on Saturday. National President, Roslyn Ridgeway updated the members on the top ten accomplishments of the organization to date. The majority of the day's business was the Amendments to the By-laws and Policies and the Procedures Handbook, and as usual it was very lively and informative. These items were forwarded to the National Conference for further consideration.
