

Everyone has a story. Everyone faces their own set of challenges. Everyone has battle scars from life. Ours may not all look the same, but they all exist.

I grew up in a typical African American single-parent family. I lived with my great-grandmother and greataunt for much of my life. My mother struggled to make ends meet as a single mother of four children and worked hard and often long hours. My mom was a teen mom, as were all five of her sisters, as was her mom. My dad was a teen dad and found trouble as his refuge from dealing with his parent's divorce. As a result, he spent much of his life in prison and survived a year outside before being killed. Both his parents died when I was in elementary school; my grandmother of cancer, and my grandfather was shot and killed because he was mistaken for someone else at his job.

#### See? Everyone has a story.

The years I spent under my great-grandmother's and aunt's tutelage were marked by the strict instruction to finish school and attend college. No one had done so within my immediate circle up to that point. Warnings to "stay away from those turkeys because all they do is gobble gobble," were bountiful, too. I was instructed to travel, do everything I wanted, and THEN get married. I didn't adhere to that, and my grandmother was more disappointed when the news came of my first pregnancy. I married at 20 and had only one semester of part-time college under my belt. I sat out a year to work and earn money to buy a car. So, I worked full-time and went to school part-time. Once I was pregnant, she thought I'd never finish school, and I suppose she also felt her investment in me would go to waste.

I married an outstanding, family-oriented guy who loved God more than anything, and we had three babies back-to-back. With Lawrence's encouragement and support, I finished my undergraduate degree in 2001 from ULM. Twenty years later, in 2021, I embarked on the journey to earn my master's degree. Lawrence and I talked

through the years about having a consulting agency specializing in people's development. We realized that goal last September. A master's in Communications would lend credibility to my resume as I pursue clients. Working more than a full-time job and going to school has been more than a notion, and I wanted to be done as quickly as possible. I didn't want to go into significant debt doing this venture, so I sought scholarships. There are not very many out there for graduate-level students.

However, the BPW offered me the opportunity to apply. I did just that and was selected as one of their recipients. That scholarship allowed me to shave off a whole semester! Instead of finishing in two years, I was able to finish in a year and a half. Currently, I have a 4.0 GPA. I hope to hold on to it through my last two classes, but one of those classes may get the better of my "A" capability!

ALL of this to say, I refused to remain a victim in my story. I am thankful for the people God put in my life and path. Business and Professional Women have been added to that very special list. Thank you for your mission and for choosing to invest in me. You impacted not only me, but every life I touch from here on out.

#### **Agnes Morris Education Scholarship Fund**

#### **Legislative Updates**

Unfortunately, as we knew would most likely happen, our ERA Senate Resolution, SJR 4, failed to make cloture on the U. S. Senate floor yesterday 04/27/23. The Senate, unlike the House, requires a procedural vote before the actual vote on the bill or resolution. This procedural vote must have a supermajority of 60 in order to pass; not just a simple majority. This procedural vote (cloture) allows a vote on the bill/resolution, if passed by a supermajority. The cloture vote on the ERA only garnered 51 votes (47 opposed), so it failed to reach cloture and the resolution itself therefore was not voted on.

This is a sad day for the ERA and its supporters, but it was also a historic day, as this was the first time the Senate resolution had a floor vote. We will have to regroup and see where we go from here, so stay tuned for updates on next steps.

In more sad news, Sen. Joseph Bouie's bill to require employers of state contract workers to obey the Louisiana Equal Pay Act of 2013 that we passed for state workers ten years ago, died in the Senate Labor and Industrial Relations Committee on Wednesday by a vote of 2-4. This used to be an easy committee to pass equal pay and other economic security legislation in, but unfortunately the make-up of this committee has changed drastically and it is no longer a supportive committee. We deeply appreciate the favorable votes we received from Sen. Regina Barrow and Sen. Royce Duplessis. Please send them and Sen. Bouie notes of thanks for their favorable votes and sponsorship, respectively.

Sen. Gary Carter's bill to increase the state minimum wage was not heard in Senate Labor on Wednesday after all but is supposed to be heard next week. Please lobby the committee members for their support prior to the vote.

Thanks to everyone who contacted our U. S. Senators re the ERA Resolution vote and the members of the Senate Labor Committee re the equal pay bill.

The Scholarship committee will review the applications and award the 3 scholarships at the Chalmette High School Award Ceremony in April.



#### STRAWBERRY SHORTCAKE POKE CAKE RECIPE



This Strawberry Shortcake Poke Cake is the perfect cool and refreshing dessert. Yellow cake with strawberry gelatin poked throughout, topped with a delicious whipped topping and fresh strawberries.

•	□ □1 Yellow Cake Mix (plus ingredients on back)
•	□ 1 small box instant strawberry JELL-O Raspberry or cherry work too!
•	□ 1 cup hot water
•	□ 1 cup cold water
•	□ 18 oz. block cream cheese softened
•	□ 1 tsp. <u>vanilla extract</u>
	□ 1/2 cup <u>powdered sugar</u>

- □2 cups whipped cream
- □2 pints strawberries sliced

#### Instructions

Make Yellow Cake by following directions on box.

- 1. Once the cake is out, take a fork and poke it all over.
- While cake is still warm, make jell-o by adding mix to 1 cup hot water and dissolving and then adding 1 cup cold water. Spoon this liquid over the top of the cake, making sure it goes through the holes made by the fork. Refrigerate for 4 hours.
